In January 2013, the Emergency Maternity Shelter (EMS) opened its doors to welcome the most vulnerable pregnant women in need of services. This collaboration between Casa Tersa, First 5 of Orange County, HomeAid OC and donors, provides a safe haven for women with minutes of sobriety, mental health challenges and typically in the last trimester of their pregnancy. Another important component to EMS is the ability to serve two pregnant women with up to three children – this remains a critical population in need. In EMS's 10 years we have served nearly 1,000 women, children and babies.

Casa Teresa has always been committed to doing what is best for the women and their children that we serve. I hope you are moved by Marcela's story. She was one of the first women in EMS 10 years ago. She has maintained her sobriety, is a working professional, in a healthy marriage with her children and her "casa baby" is thriving.

We are so grateful for your generosity. This year we served 93 women, 23 children, 36 babies and 212 alumni. We could not serve without you. YOU ARE A BLESSING.

BREAKING THE CYCLE, MAKING AN IMPACT

BEFORE CASA TERESA, MANY OF THE WOMEN:

- Come from unhealthy living situations or have been chronically homeless
- Have struggled with drug or alcohol use
- Have been physically, sexually and/or emotionally
- Are estranged from their parents and other family
- In need of their high school diploma or equivalent
- In need of prenatal care
- Unable to navigate/receive mental health resources
- Have experienced trauma

HAVE MENTAL HEALTH CONCERNS

AFTER CASA TERESA, THE WOMEN AND/OR BABIES:

- Leave with a stable place to live
- Are educated in parenting skills and child development
- Have the tools to develop healthy relationships
- Are reunified with families and older children in a healthy way
- Have earned their high school diploma or passed the high school equivalency test (HSE)
- Babies have been immunized
- Have criminal record expunged or sealed
- Connected to community resources

A STORY OF IMPACT:

MARCELA'S STORY

My name is Marcela and I came to Casa Teresa in 2013, I was 30 years old, hopeless, homeless and desperate for change. I was broken, full of fear and eight months pregnant with my second child. I had given up guardianship of my first child Nicholas and I was unemployed.

Before coming to Casa Teresa my life was unmanageable. I had been battling with a severe drug addiction and I had gone to jail numerous times. After being released in 2012, I admitted myself into a 90-day women's rehab. I completed the program and decided to go to His House, a transitional shelter. I was sober and overall doing well and after a few months of living there, my boyfriend was released from prison and I decided to leave the shelter. Two months after his release I became pregnant.



While pregnant with my second child, my boyfriend was arrested. I had no idea at the time, but he had been using again and was committing crimes. The entire situation was disheartening and I felt lost. I wanted to save him, but I wanted to save my unborn child and myself more. More than anything, I didn't want to cause harm to my daughter, the way I had my son.

My father had heard about a women and children's program through his church and he shared the information about Casa Teresa with me. He provided me with the phone number and I called.

Casa Teresa was the most welcoming home. Upon my arrival to EMS, Kim greeted me with open arms, I was so scared but she told me I was going to be okay and I believed her. I closely worked with my Case Manager Shannon and she encouraged me and supported me in every way possible. She helped me set small goals and taught me to believe in myself again. After completing EMS, I transitioned to T1 and then T2 where I worked with Nicole, she encouraged me to go back to school and

together we set bigger goals. The house moms were also amazing. I remember having deep conversations with the staff about God and my dreams for the future and I felt hopeful.

During my time at Casa, I attended life skills classes which helped me immensely and taught me how to make better choices, how to solve problems and develop new skills. The Bible study class led by Amy also played an instrumental role in developing my relationship with God and encouraged me to dive into His word.

Looking back, I believe that my feelings of desperation and being pregnant motivated me to change the direction of my life. I remember I would pray and ask God to give me the willingness to stay sober. During my time at Case Teresa I started to attend AA meetings, I got a sponsor and worked the 12 steps. I truly felt God was giving me a second chance to life and I held onto my sponsor and program for dear life.

My Casa Baby Kennedy is now 10 years old. She is full of life, loves reading and has a true passion for singing and playing both the violin and piano. She is a social butterfly and is on the Varsity Speech and Debate Team at her school. She absolutely loves doting on her two dogs and is patient and affectionate to her three siblings.

Today I have a beautiful and full-life. I have a solid 12 years of sobriety and I work for a small law firm. Kennedy's father has also remained sober since his last arrest and together we are blessed with two additional children: Rune and Finn.

Casa Teresa helped me recreate my life. I am so incredibly grateful for every single staff member and volunteer who played a role in my journey. Thank you for opening the doors to my baby, my son and I and for giving me another chance at life.




